**ANIMAL FEES**

Animal Shelter Fees (4-21-2004)

\$60.00	Impound fee
\$120.00	Impound fee in a school zone
\$100.00	Animal intake fee (voluntary surrender of an animal)
\$150.00	Observation fee
\$40.00	Adoption fee for sterilized animals

Non-sterilized animals must be sterilized within fourteen days of adoption. Once the sterilization has been completed, at the owner's expense, the adoption fee will be waived. All unlicensed, impounded dogs will require licensing before they are released to the owner.

Dog Licensing Fees

\$1.00	per month for spayed or neutered dogs (2-17-16)
\$3.00	per month for unaltered dogs
\$5.00	replacement fee for lost tag

The licensing fee shall cover the period of the current rabies vaccination, or 12 months for the annual license.

Owners that have a 3 year vaccination certificate can choose to purchase a license that will expire at the same month that the rabies expires or 3 years from time of vaccination. (Rev. 2-17-16)

Filing and Processing Fee

\$500.00 shall be paid with the filing of an annexation petition. (4-21-2004)

**ZONE CHANGE REQUEST**

Filing and Processing Fee

\$500.00 shall be paid with the filing of a request for zone change (3-1-2006)

**PLAT AMENDMENT / PLAT VACATION**

Filing and Processing Fee

\$500 shall be paid with the filing of a request for a plat amendment (5-2-2007)

**BEER LICENSE FEES**

Class "A" Retail License -- \$150.00 per annum or any part thereof

Class "A" retail license entitles the licensee to sell beer in original containers for off-premise consumption only in accordance with the Alcohol Beverage Control Act.

Class "B" Retail License -- \$250.00 per annum or any part thereof

Class “B” entitles the licensee to sell beer in original containers or on draft for on-premise consumption or off-premise consumption in accordance with the Alcohol Beverage Control Act.

Said fees shall be non-refundable upon approval of the retail license. Prior to approval of said license, the application fee shall be refunded upon request. All licenses issued shall expire on the 1<sup>st</sup> day of July of each year unless sooner canceled and shall be issued for one year only.

\$100.00 – cleaning and damage deposit. This check will be kept with the reservation and  
destroyed when the city staff verifies the room has been cleaned up and left in

Non-profit organizations will be exempt from the user fee, but the \$100.00 cleaning and  
damage deposit will be collected at the time of the reservation.

Commercial – \$29.00 per month, allows 30,000 gallons of water (Rev. 8-7-13)

Institutional irrigation-\$29.00 per month, allows 30,000 gallons of water with next 200,000 gallons for .50 per 1000 gallons and 201,000 gallons or more for .55 per 1000 gallons. (Rev. 8-7-13)

Institutional culinary-\$29.00 for 30,000 gallons of water with next 20,000 gallons for .40 per 1000 gallons and 50,001 gallons or more for .65 per 1000 gallons. (Rev. 8-7-13)

Residential Meters Larger than 1-inch - The monthly user fee shall be the same as the regular monthly user fee based on 30,000 gallons of water usage for the minimum billing.

Hydrant Meter – A \$1000.00 cash deposit will be required before the fire hydrant meter may be used. A \$29.00-fee plus \$1.00 per 1,000 gallons of water used or any fraction thereof will be assessed for the use of water from a fire hydrant. An additional \$29.00 per month will be charge for a meter not returned within the first month. The deposit will be refunded when the fire hydrant meter has been returned and all charges for water use are paid. Six months is the maximum time a fire hydrant meter may be used. (Rev.12-20-17)

Hydrant valve- A \$400.00 deposit plus \$29.00-for the first month’s water usage will be paid in advance when checking out a hydrant valve. The monthly charge will be \$29.00 for water usage of 30,000 gallons or less. (Rev. 12-20-17)

Late penalty/Administrative fee

A 10% penalty will be assessed on the unpaid utility balance at the time of the next utility billing.

Deposit:

Regular - \$200.00 new customer deposit, unless a proven one year positive payment record is presented from two previous utility providers. The deposit will be held for one year of on time payments and then it may be applied to the owners account as a credit. If the owner does not have a year of on time payments the deposit will stay on file until the account is terminated. On final settlement of applicants account, any unused balance of the deposit will be refunded to applicant.

Renter/Property Manager Deposit:

A \$200.00 deposit will be required when a renter or property manager is approved by the property owner and staff to set up the utility account. The deposit will be held on the account for the time frame that the account is in the renter or property manager's name. On final settlement of applicant's account, any unused balance of the deposit will be refunded to applicant. The renter or property manager cannot put a sublease on the account. Renter/Property Manager accounts are not eligible for a deposit waiver. (Rev. 1-2-13)

Mobile Home Park - \$125.00 new customer deposit, unless a proven one year positive payment record is presented from a previous utility provider. Refunded when service discontinued at customers request and all payments due Enoch City are paid in full or after one year of a positive payment record.

Commercial, Industrial and Institutional - \$200.00 new customer deposit, unless a proven one year positive payment record is presented from two previous utility providers. The deposit will be held for one year of on time payments and then it may be applied to the owners account as a credit. If the owner does not have a year of on time payments the deposit will stay on file until the account is terminated. On final settlement of applicants account, any unused balance of the deposit will be refunded to applicant. (Rev. 8-7-13)

Contractors - \$200.00 deposit paid with connection fee, with billing starting when new meter is installed.

Connection Fee:

\$350.00 for a 1-inch residential water connection where the lateral connection is "installed by the developer." (Rev. 2-18-15)

\$750.00 for a 1-inch residential water connection where the lateral connection is "installed by the city." (Rev. 2-18-15)

\$500.00 for a residential lot with a secondary water system for a 1-inch culinary water lateral connection and a 1-inch secondary water lateral connection." (Rev. 2-18-15)

\$700.00 for a 1-inch residential water lateral connection outside city limits. (Rev. 2-18-15)

\$1,300.00 for a 1½" or 2" for a residential water connection where the lateral connection installed by the developer. (Rev. 2-18-15)

\$2,000.00 for a 1½" or 2" meter for a residential water connection where the lateral connection installed by the city. (Rev. 2-18-15)

Multiple residential dwelling units - A lateral connection for multiple residential dwelling units shall require a regular 1-inch lateral connection fee for each dwelling unit and an individual 1-inch water meter for each dwelling unit. (Rev. 9-21-11)

Water Right Requirement: (6-1-2005)

The water right requirement for each residential lateral connection shall be one-acre foot of water per lateral connection.

The water right requirement for multiple residential dwelling units shall be one-acre foot of water per dwelling unit.

The water right requirement for commercial, industrial and institutional lots shall be based on meter size. AF=acre foot

1” = 1 AF      1 ½” or 2”= 4 AF      3”=8 AF      4”=14 AF      (Rev. 8-7-13)

When deeding water to Enoch City, the water right must be in the Cedar Valley Drainage on the north side of Highway 56 with a water right prefix of 73. A history will be required of the water right that has been used on the property as well as the water right being deeded to Enoch City, if different.

Water Right Transfer Fee

\$50.00      For each Conveyance Report required to transfer the water right.

Up to \$250.00      For each Change Application required to transfer the water right.  
Charge is dependent on number of AF. (Rev. 4-21-2004)

\$50.00      For each Segregation of water rights application. (Rev.4-6-11)

Lateral Water Lateral connections:

\$5.00 per foot to extend a lateral water line from the main water line to the location of the water meter when the lateral water line has not already been installed and paid for.

Water line extension fee:

When the city extends a water line at city expense, making a water lateral connection possible for a piece of property, a line extension fee shall be charged before the property can be connected to the water line. This fee will be based on the proportional share of the installation costs at the time of installation, if paid at the time of the installation or the proportional share of the current installation costs at the time of the lateral connection, if paid at the time of lateral connection. The installation costs shall include minimum pipe size, minimum depth, fittings and required fire hydrants.

Fee to turn water on and off for inspection purposes

\$25.00 Fee must be paid before water will be turned on. (6-2-2004)  
\$25.00 Call out fee for extra water turn on/turn off

Water Restriction

No outside watering between the hours of 10:00 a.m. to 6:00 p.m. from May 15 through October 15 of each year. A \$30.00 reconnect fee will be charged if the water is turned off for a violation.

Fee for installation of water line along Eden Way (5000 North)  
02-02-2005 - \$2,240.00 per lot or lateral connection (material \$29,097 + digging \$4,500 = \$33,597 divided by 15 lots = \$2,239.80)  
Future – Cost of materials and installation, at the time of request for lateral connection, divided by 15 lots.
