**RULES, REGULATIONS AND DEFINITIONS FOR**  
**HYDRANT METER & HYDRANT VALVE USE**

**Hydrant Meter** is a large meter that is commonly used for subdivision construction and road installation, etc. It is metered and billed by the monthly water usage and rental fee. Meters will be submitted to the Water Superintendent to be read and inspected by the 10<sup>th</sup> day of each month.

Customer will contact the Enoch City office to request that the meter be picked up for termination of account, or if the meter will be moved to another work site. Hydrant meters require a hydrant key for placement on the fire hydrant. Do not attempt to remove meter without an approved hydrant key. Deposit requirement is \$1,000.00 with the first month's rental fee of \$29.00. Meter billing is \$1 per every 1000 gallons plus \$29.00 a month rental fee.

**Hydrant Valve** is a small non-metered valve that connects to a fire hydrant. It is commonly used for single family home construction, hydro seeding, back fill, and soil compaction. Billing for the valve is a flat rate of \$29.00 a month. A deposit of \$200.00 and a first month usage fee of \$29.00 are required before the valve can be picked up.

**Rules and Regulations:**

Customer will need to contact the Enoch City office to schedule the use of either a meter or valve. Customer will need to complete the application for service and pay the required deposit and usage fee prior to receiving the meter or valve. Customers will submit the meter or valve to the Water Superintendent by the 10<sup>th</sup> of each month for reading and inspections. Failure to submit meter or valve for reading and inspection will result in a \$250.00 monthly penalty. If a customer fails to return the meter or valve after three months the customer shall forfeit the deposit and shall be subject to further penalties

Any use of City water from a source where permanent connection has not taken place without a meter as provided herein shall be unlawful. Any person violating any provision of this Ordinance shall upon conviction be punished by a fine not exceeding one thousand dollars (\$1,000.00) or by imprisonment not exceeding six months (6), or by both such fine and imprisonment.

Customer agrees to maintain hydrant meter or valve to avoid damage caused by freezing during winter months. The City recommends the valve be drained each time it is removed from the hydrant. If the meter or valve is lost, stolen or damaged, customer will be required to replace at the customer's expense.

**Deposits:** After termination of an account, the amount due will be applied to the deposit and then a refund check for the balance will be issued.

Please contact the Enoch City office for all correspondence regarding the meters or valves. The person, persons or entity to which a meter or valve is issued accepts all liability for any loss, damage or injury sustained by any persons or entity to which such meter or valve is issued.
