ENOCH CITY CORPORATION ORDINANCE NO. 2023-03-01

AN ORDINANCE ADOPTING THE REVISED GENERAL PLAN AND THE GENERAL PLAN LAND USE MAP

PREAMBLE

As required by State law and in order to provide for the health, safety and general welfare of the citizens of Enoch City, Utah, the Enoch Planning Commission and Enoch City Council are committed to establish a General Plan which will specify goals, relating to land use, housing, the environment, transportation and public facilities, and services, which the residents of Enoch City hope to achieve in the future and those policies which will facilitate those goals.

The Planning Commission completed an extensive revision process to update this General Plan and to include all State required elements.

WHEREAS, the City desires to adopt a revised and updated General Plan to be known as the Enoch City General Plan and General Plan Land Use Map; and

WHEREAS, the Enoch City Council is authorized to adopt a general plan; and

WHEREAS, the General Plan may address issues relating to land use, transportation and traffic patterns, the environment, public services and facilities, rehabilitation, redevelopment and conservation, the economy and recommendations for implementing the plan; and

WHEREAS, Utah State Code, Title 10, Chapter 9a, sets forth procedures for the adoption and content of a General Plan; and

WHEREAS, the Planning Commission of Enoch City held a duly advertised and noticed public hearing at a regular Planning Commission Meeting on February 28, 2023 for the purpose of receiving public comment regarding the content of the General Plan; and

WHEREAS, the City Council of Enoch City has reviewed the Revised General Plan and received a favorable recommendation from the Enoch City Planning Commission advising them to adopt the Revised General Plan:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of Enoch, Utah, as follows:

(1) The General Plan attached is hereby adopted as the revised Enoch City General Plan and General Plan Land Use Map.

- (2) All ordinances adopted subsequent to this General Plan shall comply with the goals and policies as set forth herein.
 - (3) This ordinance shall take effect immediately on passage.

This ordinance was made, voted upon, and passed by the Enoch City Council at a regular city council meeting held on the $1^{\rm st}$ day of March, 2023.
